Pre Requisite(s)

Pre-course study

Learners <u>must</u> be allocated time to study prior to attending the assessment process, this will be managed by the Learner's Line Manager and the Learner.

Learners are required to undertake study in the PTA Safeworking Rules before attending the reassessment. There will be no retraining on the assessment day.

Pre Requisite(s)

Safeworking breaches

Any safeworking breaches involving the Learner in relation to Protection Officer Level 1 (PO1) during the eligibility period will deem the Learner ineligible for this process. To become reaccredited or to maintain PO1 the Learner must attend a full training course of three (3) days duration.

Learner Requirements

SW and PO1 training and assessment.

All Learners will be required to bring the following on the day of assessment:

- RIW card
- Full PPE (Steel cap boots, high vis clothing as required)
- Mobile phone with Staysafe and Pegasus (RIW) app downloaded and working

Note: failure of the Learner to bring the above items will render them ineligible to undertake the practical assessment.

Unsuccessful Learners

Learners that do not successfully pass the theory or practical assessments on their first attempt will not be eligible to continue. Track Access accreditation levels (SW and PO1R) will be removed from the RIW card. Learners will be required to register for a full training course as soon as practical.

Where full training is required for an unsuccessful result in PO1R the Learner will be required to successfully complete the following:

- Supervised Worker (SW) 1 day Training & Assessment
- Protection Officer Level 1 (PO1) 3 days Training & Assessment

Note: There will be no second assessments on the day. Line Managers and Learners must be aware where a Learner is unsuccessful they will be removed from the course and both SW and PO1 status removed effective immediately. Careful consideration must be given to how this may affect work schedules before registering Learners for the reassessment.
